## Northern Pass Permitting Process History (2010-2014)

#### Presidential Permit Application and First Scoping Hearings

October – December 2010. First announcement of NPT to New Hampshire public, in Franklin, followed by meetings with select boards of towns along the route.

**October 2010.** NPT submits Presidential Permit application with several route alternatives to DOE. No border crossing specified.

**February 2011**. NPT updates PP application, identifying border crossing and two alternatives in Pittsburg.

<u>March 2011</u>. DOE holds scoping hearings on PP application in seven NH locations. A firestorm of protest erupts.

**April 2011**. NPT takes alternative routes off the table as "lacking public support," narrows to its existing ROW, and asks that scoping be extended 60 days while it "improves" its route in Coos County.

#### Two years later...

Amended Presidential Permit Application and Second Scoping Hearings

**June 2013**. NPT files Amended PP application with new (but still incomplete) Coös route.

**September 23-26, 2013**. DOE holds second round of scoping hearings in four locations. Protest continues.

November 2013. Scoping period closes.

March 2014. DOE publishes initial scoping report.

<u>April 2014</u>. NPT "modifies" the route again, moving approximately 900 structures, files changes with DOE, which to date has not released this information.

<u>May 1, 2014</u>. DOE publishes Addendum identifying 24 alternatives suggested in Scoping comments.

## Projected Future Timeline of Northern Pass Permitting Process

**Late 2014/early 2015:** DOE issues <u>Draft</u> <u>Environmental Impact Statement</u> and sets public hearings and comment period.

Late 2014/early 2015 (exact dates unknown, following release of <u>draft EIS):</u> NPT applies for approval to the New Hampshire Site Evaluation Committee for a certificate of site and facility for the project; public proceedings and hearings follow.

**2015-2016:** DOE issues <u>Final</u> Environmental Impact Statement.

**<u>2015-2016</u>**: DOE issues final decision on Presidential Permit for the project.

**2015-2016**: United States Forest Service (White Mountain National Forest), United States Fish and Wildlife Service (Silvio O. Conte Fish and Wildlife Refuge), and Army Corps of Engineers issue final decisions on permit applications (if applicable) for the project.

## **RSA 162-H: ENERGY FACILITY EVALUATION, SITING, CONSTRUCTION AND OPERATION**

## Excerpt from 162-H:16 Findings and Certificate Issuance.

IV. The site evaluation committee, after having considered available alternatives and fully reviewed the environmental impact of the site or route, and other relevant factors bearing on whether the objectives of this chapter would be best served by the issuance of the certificate, must find that the site and facility:

(a) Applicant has <u>adequate financial, technical, and managerial capability</u> to assure construction and operation of the facility in continuing compliance with the terms and conditions of the certificate.
(b) Will not unduly interfere with the <u>orderly development of the region</u> with due consideration having

been given to the views of municipal and regional planning commissions and municipal governing bodies.
(c) Will not have an unreasonable adverse effect on <u>aesthetics, historic sites, air and water quality, the</u> natural environment, and public health and safety.
