## Support private property rights with the Forrester/Bragdon Amendment

To the Editor:

Tomorrow morning, the New Hampshire Senate will be taking up a very important bill, HB 648, which was written to protect private property rights. The bill is getting a lot of attention because of the proposed Northern Pass project.

HB 648 has been languishing in the Senate since June, when they decided to send it back to the Senate Judiciary Committee for further study. Last month, the committee gutted the original wording of the bill and replaced it with pages of language that do nothing to prevent private utility developers from taking your property for an optional, for-profit project. The committee's amended version actually loosens the state's eminent domain laws and puts all property owners in New Hampshire at risk.

The full Senate will be voting on HB 648 and recommendations by the committee. I urge all of your readers to contact their senators today and ask them to reject the committee's recommendation and instead pass the "Forrester/Bragdon Amendment."

What HB 648 seeks to do is amend the current RSA 371:1 which states: "No public utility may petition for permission to take private land or property rights for the construction or operation of an electric generating plant."

The Forrester/Bragdon Amendment would add: "or for any private development, including but not limited to participant-funded projects."

The language is clear. The threat of Northern Pass to property rights is real. But this isn't just about Northern Pass. It's about bringing New Hampshire's eminent domain statutes up to date with Article 12-a of the N.H. Constitution which was passed by over 85 percent of the people in 2006 in response to the Kelo vs. New London decision. It's about protecting private property from other similar projects that have already been mapped out across New Hampshire. Could you imagine 135-foot tall steel towers being run through Andover, Wilmot, New London, Sunapee, Springfield, Croydon, Newport and Claremont and many people losing their property to make way for such a project where the profit and electricity go to another state or even another country? That line has already been drawn and is on file at the Public Utilities Commission! Visit www.briantilton.com/Northern-Pass.html and scroll down the "New Hampshire Gold Rush" postings of Dec. 15-17.

Northern Pass is on record in federal filings, interviews and testimony that this project relies heavily on eminent domain. They brought it up first! One lie that has been told by

PSNH/Northern Pass lobbyists is that if HB 648 passes, there will never be another renewable energy development project in the state again.

FACT: After the adoption of Article 12-a five years ago, large new wind farms in Lempster and Dixville have been built, a major new biomass plant in Berlin has been proposed and approved, PSNH has completed its \$430 million new scrubber, and many other smaller energy developments have been successfully completed. There is obviously nothing in Article 12-a or HB 648 - that discourages new energy projects by companies that are willing to forego unconstitutional abuse of eminent domain.

Sen. Andy Sanborn is already on record supporting these property rights protections. Sen. Bob Odell and Sen. Matt Houde both voted in June to send the bill back to committee. Sen. Houde voted in committee to weaken our eminent domain laws. Please call both of those senators today and ask them to support private property rights with the Forrester/ Bragdon Amendment.




